## Resolved Issues

- **AGT-38945 [CS1310061]: Performance issue on MSSQL cluster servers**

CTE agent was leaking a volume context, as well as occasionally leaking a filter volume, if a guard process or volume access was occurring concurrent to the volume dismounting. Once a Windows filter manager limit reached a leaked filter volume, it prevented the filter manager from releasing any further volume instances. The instance counts seen in `fltmc` would then increase in an unbounded manner. The leaks and this issue have been fixed in the current patch release.

- **AGT-40692 [CS1310061]: Crash occurred during failover**

The crash was caused by the race condition between LDT processing and GuardPoint processing. This condition happens rarely. This race condition has been fixed in the current build.
